

Innersphere Terms of Service

These Terms of Service ("Terms") govern your access to and use of the Innersphere mobile application ("App") and any related services provided by Innersphere ("we," "us," or "our"). Please read these Terms carefully before using the App.

By accessing or using the App, you agree to be bound by these Terms. If you do not agree to these Terms, please do not use the App.

1. Use of the App

- 1.1. License: Subject to these Terms, we grant you a limited, non-exclusive, non-transferable, and revocable license to use the App for your personal, non-commercial use.
- 1.2. Access: You may access and use the App solely for lawful purposes. You agree not to use the App in any way that violates any applicable law or regulation.
- 1.3. Google APIs and Firebase: The App utilizes Google APIs and Firebase services, and your use of these services is subject to the Google Terms of Service (<https://policies.google.com/terms>) and Firebase Terms of Service (<https://firebase.google.com/terms>).
